

## What are Regulations?

Regulations are binding, formal standards for how the agency implements legislation

The Executive generally must request, review and respond to comments by the public/interested parties before finalizing rules

Anyone can submit comments on regulations, and there is no specific format required.

## Why is commenting important?

Raising your Voice, Raising Concerns

- This is a great way to let your voice be heard in support of issues you care about and good governance
- Comments create a record of concerns that can be raised in future litigation

Commenting on Regulations Related to T Visa

#### What is the T Visa?

- Non-immigrant visa for victims of trafficking
  - Allows holder to remain in the U.S. in T nonimmigrant status for up to four years
- Created by the Trafficking Victims Protection Act and its reauthorizations (TVPRA)
- Purposes:
  - Support/protect noncitizen victims of trafficking
  - Encourage noncitizen victims of trafficking to report and cooperate with law enforcement without fear of immigration consequences

T Visa Regulations Describe who is eligible for a T visa as a victim of trafficking

Detail who is eligible as a derivative of the applicant

Outline bars to eligibility and waivers

Detail which law enforcement agencies can sign endorsements

#### Bars to T visa eligibility for people removed

Employment authorization while T application pending

Protections in removal proceedings for trafficking victims and derivatives

Protections for minors who are victims

Involvement of state/local law enforcement agencies



## How to Comment



What to Include in a Comment Who you are and why you are interested

include personal or professional interests, background, experience with trafficking, etc.

Summary of your top concerns or suggestions

**Detailed outline of your comments and suggestions** 

Include references to regulation number, etc. where possible

Include data or other evidence if available

PERSONALIZE the information

### **Format of Comments**

No required format- this does not have to be written like a brief or other legal document



Comments must be submitted online



Any length is acceptable



You can, but are not required to, sign your comment

Provide your name and contact information

The government must *receive* your comment **by September** 14, 2021
