Refugee and Immigrant Rights: The Advocates provides legal representation to asylum seekers and immigrants in the Upper Midwest and around the United States. With pro bono assistance from hundreds of attorneys, The Advocates is the primary legal service provider to low-income asylum seekers in Minnesota, North Dakota, and South Dakota. The Advocates has expanded legal services to include services for youth who are victims of labor trafficking. During FY2020 The Advocates provided more than 1,500 people with legal help and the National Asylum Help Line linked to more than 1,250 asylum seekers with help following release from detention. In addition to legal services, The Advocates collaborates on the Immigration Court Observation Project to engage hundreds of volunteers in monitoring detained immigration court hearings.

Women's Human Rights: The Advocates has more than 25 years of experience working with partners in Minnesota and around the world to document problems in the government response to violence against women. WATCH, the premier court monitoring organization, is now a project of The Advocates, enhancing protections for women in Minnesota and opportunities for training and technical assistance for The Advocates' global women's human rights partners.

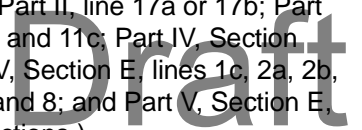

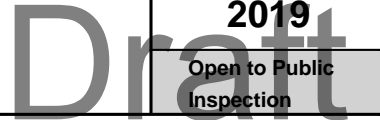
